ONGOING AND UPCOMING ACTIVITIES

Christiane De Boeck (CF Core) has been nominated on behalf of ERN-LUNG to the Task Force on Clinical Research Networks (CNR) of the Interdisciplinary Scientific Committee (ISC) of the International Rare Diseases Research Consortium (IRDiRC). Having been the first director of the ECFS CTN (European Cystic Fibrosis Society Clinical Trial Network), she has been involved in all crucial steps of setting up and managing this very successful example of a CTN bringing therapies to patients in the field of rare diseases (RD), therefore we expect her to be able to give extremely valuable input to this task force.

Thomas Wagner (CF Core) and ePAG representative Gergely Meszaros have been nominated to the **Rare 2030 Panel of Experts**. A continuation of the policy-related activities of RD-ACTION, the European Joint Action for RD, Rare2030 is a new strategic participatory foresight study to reflect on the long-term future of people living with a rare disease in Europe and to provide policy recommendations through 2030 and beyond. Petra Pennekamp (PCD Core) will be representing ERN-LUNG at the focus group meeting of Workpackage 17 of the **European Joint Programme Co-fund on Rare Diseases (EJP-RD)**. The objective of this meeting will be to develop the ERN research training program based on the results of an EJP-RD survey on preferences, needs and resources from the ERNs ecosystem. Thanks to ePAG representative Liam Galvin, we have the received the support of the European Idiopathic Pulmonary Fibrosis and Related Disorder Federation (EU-IPFF) for the **development of a pathway project** on the topic of "undiagnosed patients with respiratory problems/symptoms - from GP to ERN". At the moment Helge Hebestreit (ILD Core), Annick Clement (AATD Core), Thomas Wagner (CF Core), Liam Galvin and Keerthana lyer are participating.
